The purpose of this Request for Proposal (RFP) is to assist with providing a Telecommunications network for the Qanuippitaa? National Inuit Health Survey in Nunavut, prior to and during data collection that will be conducted between September 2023 to June 2024.

Background

Nunavut Tunngavik Incorporated (NTI) is the representative organization for Nunavut Inuit under the 1993 Nunavut Agreement, a comprehensive land claims agreement. NTI's mission is to advance Inuit economic, social and cultural well-being through the full implementation of the Nunavut Agreement. Scope of Work

The Qanuippitaa? National Inuit Health Survey is being implemented by the national Inuit Organizations at the national and regional levels, including core and regional components to the development of the survey, with the objective of further surveys every five years for long-term monitoring.

The successful proponent shall provide

- the high-speed internet connectivity for our Qanuippitaa Servers in Iqaluit;
- reserved IP address for our qnihs.ca domain;
- satellite dish (if needed for the internet connectivity) and a fiber optic connection from our building to the satellite dish;
- secure space (locked up) for a backup server in Iqaluit; and
- setup, installation, and support for any required equipment.

Submissions and Inquiries

An interested firm or individual (Proponent) may submit a hard copy and/or an electronic copy of their proposal. Hard copies should be in a sealed envelope or other sealed packaging, clearly marked on envelope/packaging with the name of this RFP.
