Experience and willingness to learn is accepted. We encourage you to apply if you have the equivalent experience.

- Have business and regulatory background that would prove to be an asset to the Council's operations.
- Can commit the time to attend hearings and the time necessary to study and evaluate the matters brought before the Council.
