THE KITIKMEOT LAW CENTRE SEEKS A BOARD MEMBER TO BE THE KLC REPRESENTATIVE FOR THE LEGAL SERVICES BOARD OF NUNAVUT

The Kitikmeot Law Centre (KLC) will call a Special Meeting in early June in order to appoint a Board member to the Legal Services Board of Nunavut (LSB). In order to be eligible, the individual must be prepared to also be on the KLC Board of Directors.

The KLC Board which meets 6 – 8 times per year in Cambridge Bay or if residing outside the hamlet participates by teleconference/online video conference calls. As the KLC representative on the LSB, the person would need to commit to attending LSB meetings up to 4 times per year (up to 2-3 meetings in person per year plus additional meetings when required by video conferencing). As the KLC representative, the member would be further expected to bring KLC issues to the territorial board and report back LSB information to KLC.

Tamnaupluni KLC-kut kivgaqtuiyi talvani LSB-kut, tamna inuk piyaqaqpiartuuq ilauniq LSB-kut katimanit tikitlugu 4 amihuiqtaqni ukiumi (tikitlugu 2-3 katimanit tautugutilutik ukiumi ilaplugitlu katimanit piyaqarangat qaritauyakkut tautugutiplutik katimanit).
